Duration of Membership

The minimum period is 12 months. Should a member decide to terminate membership within the 12-month period, then they remain liable for the full annual fee. No refunds can be given, and membership is non-transferable.

Termination of Membership

A member may terminate their membership by giving written notice at least three months before their renewal date. If no such notice is received the member will be liable for the ensuing year, which shall be debt due to, and legally recoverable by the Chamber.

- If there are any changes to the amount, date, or frequency of your Direct Debit Sussex Chamber of Commerce will notify you 5 working days in advance of your account being debited or as otherwise agreed. If you request Sussex Chamber of Commerce to collect a payment, confirmation of the amount and date will be given to you at the time of request.
- If an error is made in the payment of your Direct Debit, by Sussex Chamber of Commerce or your bank or building society, you are entitled to a full and immediate refund of the amount paid from your Bank or Building Society - If you receive a refund you are not entitled to, you must pay it back when Sussex Chamber of Commerce asks you to.
